Travel Sweepstakes – Official Rules

If the recruiting Consultant attended Leadership Summit and recruits at least two recruits whose Independent Consultant Agreements are received in the Home Office in the Qualifying Period and who qualify within their first 30 days, Consultant will receive two entries into the random drawing for each such recruit.
